Executive Summary

The third 2.5-day project mission, attended by representatives from the Institute of Statistics of the Federation of Bosnia and Herzegovina (FIS), the Republika Srpska Institute of Statistics (RSIS), and the Agency for Statistics of BiH (BHAS), successfully advanced the efforts to develop new construction and real estate (CRE) indicators.

The mission focused on reviewing and implementing a pilot survey for two new CRE indicators: construction starts and works completion. All three statistical institutions jointly developed and pilottested two questionnaires in April/May 2025.

Key findings from the pilot survey highlighted good cooperation from reporting units, ease of questionnaire completion, but also identified issues like some missing data (e.g. building permit numbers) and complexity, when municipal inspectorates are responsible for areas in multiple municipalities.

Based on the findings from the pilot, participants agreed to:

- Add a municipality code column to the works completion questionnaire.
- Emphasize the importance of providing complete data in notification letters for all three linked surveys.
- Prepare results (i.e. usable floor area data for construction starts and works completion) by CPA (classification of products by activity) classification by leveraging existing building permit information.

Finally, the pilot study highlighted the need to consider and design an IT application for data entry for reporting units when introducing these new real estate surveys as a regular task, given their close link to the existing collection of building permit data.

1. General comments

This mission report was prepared within the EU Twinning Project "Further Development of the Statistics System in Bosnia and Herzegovina". It was the 3rd mission devoted to the Commercial Real Estate Indicators (CREI) Subcomponent of the Project.

The purposes of the mission were:

- Analyses of the conducted pilot survey
- Discussion on the issues encountered
- Revision of questionnaires based on the inputs from pilot survey
- Preparation of ToR for next activity

The consultant would like to express her thanks to all officials and individuals from Bosnia and Herzegovina met for the kind support and valuable information, and which highly facilitated the work of the consultant.

2. Assessment and results

In early June 2025, the third 2.5-day mission on CREI in this project was successfully completed. Representatives from the Institute of Statistics of the Federation of Bosnia and Herzegovina (FIS), the Republika Srpska Institute of Statistics (RSIS), and the Agency for Statistics of BiH (BHAS) attended. The mission primarily focused on reviewing questionnaires and instructions for the pilot survey, implementing data collection for two new Construction and Real Estate (CRE) indicators (construction starts and works completion), analyzing results, and discussing the information gathered.

Two questionnaires were prepared for the implementation of the pilot survey: one for the construction starts and another for the works completion. Alongside these, instructions for completion and a notification letter for reporting units were prepared. All three institutions meticulously reviewed and coordinated the content of these questionnaires and notification letters in the preceding months. Examples of these materials are provided in Annex 4.

Data collection took place in April and May. The questionnaire for construction starts was sent to municipal inspectorates, while the questionnaire for works completion went to municipal departments responsible for issuing use permits.

The RSIS sent both questionnaires to all relevant reporting units, specifically 59 municipal inspectorates and 64 municipal departments responsible for issuing use permits. They received responses from 45% of inspectorates and 58% of municipal departments. The FIS selected 20 reporting units and successfully obtained data from all of them. The Agency for Statistics of BiH in Brčko District also managed to collect some data. Detailed information on data received is in Annex 5.

After reviewing the collected data and information, representatives from RSIS, FIS, and BHAS highlighted several key findings from the pilot survey:

- Excellent Cooperation: Reporting units demonstrated very good cooperation, though some phone calls were necessary to obtain all required data.
- Ease of Completion: Reporting units found the questionnaires easy to fill out and appreciated their concise nature.
- Missing Information: Some questionnaires lacked specific details, such as building permit numbers.
- Area Coverage: Certain municipal inspectorates cover multiple smaller municipalities, as these smaller municipalities may not have all dedicated departments.

Based on these findings, participants later in the discussion agreed to add a column for the municipality code to the Works Completion Questionnaire. Given that data from these two new CRE surveys are linked to the building permit survey via the building permit number, it was also decided that notification letters for all three surveys should in the future explicitly emphasize the importance of providing complete data.

Furthermore, all three institutions should now prepare final results, i.e. data on usable floor area for both construction starts and works completion. This data will be obtained from a survey of issued building permits via the building permit number. If any information is missing from the questionnaires, the institutions will endeavour to obtain it from reporting units in the coming months.

Since the draft regulation for these new CRE indicators requires the preparation of the results according to the CPA classification, some time at the meeting was also dedicated to this topic. The consultant prepared a table linking codes from the CPA classification with the existing CC classification (classification of types of construction). Required breakdown according to CPA classification and link to CC classification are available in Annex 6.











The pilot survey also underscored the close relationship between collecting data for these new CRE indicators and the survey on issued building permits, often involving the same reporting units. Therefore, when establishing these new CRE surveys as a regular task, it would be beneficial to consider and plan the development of an IT application for data entry for reporting units.

4. What to do before the next mission

Since the BiH institutions already implemented the pilot survey on the two CREI indicators (construction starts and works completion) with success, it has been agreed that there would be no more missions within this twinning project.

INSTRUCTIONS FOR COMPLETING THE CONSTRUCTION COMPLETION REPORT -**ISSUED USE PERMITS (M KPS GRAĐ-ZG)**

The monthly pilot survey on works completion (for the Commercial Real Estate Indicators - CREI survey) (K KPS GRAĐ ZG) is conducted based on the Law on Statistics of BiH (Official Gazette of BiH, No. 26/04 and 42/04 and the corresponding entity laws on statistics).

The survey covers building construction facilities (only new residential and non-residential buildings), except for: Residential buildings for community housing.

This activity **does not** include temporary **building construction facilities** that need to be legalized, as well as civil engineering facilities (all facilities that are not included in building construction facilities: highways, roads, streets, railways, airport runways, bridges, ports, dams, pipelines, communication and power lines, complex construction facilities in industry, etc.)

The monthly report on the works completion is compiled by the appropriate administrative bodies units that are responsible for issuing use permits (departments, services, sections, sectors) at the municipal/city, cantonal or entity level.

One report is completed for the area of each municipality/city (M KPS GRAĐ-ZG). The report includes the name of the municipality/city in whose area the subject facilities for which use permits were issued were built.

In the event that no use permit was issued in the reporting month, a Report (M KPS GRAD-ZG) for that reporting month is submitted with a zero (0) answer to question 5.

Report (M KPS GRAÐ-ZG)

For questions 1, 2 and 3, data on the reporting unit that completes the report on issued use permits is entered. For question 4, the name of the municipality/city on whose territory the relevant facilities were built and for which the appropriate use permits were issued is entered. For question 5, the reporting unit is required to enter the number of use permits issued for the given municipality/city in the reporting month, which is proportional to the number of use permits issued. In the space provided for this, the time (in minutes) spent completing the report should be entered. In the space provided for comments, enter all comments, remarks and suggestions that may help improve this activity.

For each issued use permit, two reports are completed (M KPS GRAĐ-ZG), one of which is submitted to statistics, while the other is retained by the reporting unit. All data related to the use permit are entered in the table on the second page of the report.

Report number Data from the first processed use permit issued in the reporting month are entered in the report and assigned number 1, the next issued use permit is designated as number 2, etc. The number of the last issued use permit must be equal to the number of issued use permits entered in response to question 5 of the report (M KPS GRAĐ-ZG).

Construction permit (decision) number Enter the number of the issued construction permit (decision) assigned by the competent authority for issuing construction permits within its records.













Use permit (decision) number Enter the number of the issued use permit (decision) assigned by the competent authority for issuing use permits within its records.

<u>Date of construction start</u> (date of issuance of the use permit) Enter the day, month and year of the issued use permit (decision) assigned by the competent authority for issuing the use permit within its records.
